


I've been able to pick up some tricks from his work that we can hopefully add to our own and help us keep producing great dinners that are delicious while bringing the cost down for our members.


Vice Commodore's Message

hile on the subject of reciprocity, many miss-conceptions and questions have come up that membership in PICYA automatically confers reciprocal privileges among all PICYA member clubs. That is not the case. PICYA supports every club's right to establish its own policies with respect to visiting privileges. The Gold page section and club page of the PICYA Yachting Yearbook shows information regarding each club. In many cases you can also find out about reciprocal privileges and procedures on Yacht Club Web pages. If you are interested in visiting a yacht club here are a few easy courtesy procedures.

- Verify if there is a club reciprocal privilege and follow any required procedures.
- Call ahead to ensure space is available, that your visit will not conflict with other club functions and so the club can make any necessary arrangements.
- Always ask about club and marina rules, i.e. pets, parties, electrical hookups, etc.
- Always sign the guest register.
- Always have your current TIYC Membership card and YCA card and be prepared to present it/them if requested.
- Wear a TIYC nametag. A traveling nametag can be ordered through Joyce.
- Ask for or review a copy of the club rules and observe them, as the members of that club must. Please remember you
 are a guest in their club/house. Just as a guest at TIYC should respect and follow our club rules, we should do the same
 when visiting other clubs.
- Please be courteous with club employees and members.
- If you are planning a TIYC cruise, please make arrangements early in the year with the appropriate officials and maintain the contact giving adequate information and than you.
- When visiting a Yacht Club's marina, please patronize the facilities of the club just like you would want them to do at TIYC. They, like us, may have brought in extra staff and provisions for your visit. So please make reservations with our cruise leader early and cancel if you are not able to attend a cruise.
- Under no circumstances board or make fast to any vessel, unless directed or after obtaining permission.
- Do not use hoses, stairs, mops, or other materials belonging to a slip holder without permission of the harbormaster or owner.
- Many of us leave lines, particularly spring lines at our slips to use in docking upon their return. Never use or re-tie these
 lines, as your action could cause serious damage to returning vessels and crews.
- Please follow good environmental practices i.e., trash disposal, vessel discharges and leave a clean wake.
- IT is a good practice to follow up you visit with a thank you note mentioning any members or employees who were particularly helpful.
- If needed, please let TIYC Commodore know well in advance so that any there is ample time for correspondence or letters of introduction.

"Human Ballast" a serious safety issue left unchallenged!

n the late 90's I participated in the investigation of several incidents of pontoon excursion/tour boats capsizing in the Naples/Fort Myers Florida area due to overloading. More recently there were several small ferry and tour boats that capsized on the East Coast that caused fatalities due to overloading. The National Transportation Safety Board (NTSB) has recommended that vessel capacity plates reflect the overweight/obesity problem now prevalent in the U.S.

According to the National Center for Health Statistics, between 1999 and 2000 the average American male weighed a whopping 190 lbs. Our female counterparts should not smile as the average female tips the scales at 163 lbs. We are getting bigger rapidly and the capacity plates on our boats haven't kept up.

In 2004, the NTSB recommended that the Coast Guard revise its average body-weight standard of 140 lbs. after a tour boat capsized in Maryland. One year later the standards faced even more scrutiny after another capsizing in New York, in both cases the NTSB found that each passenger weighed nearly 30 to 40 lbs. more than the average weight that the capacity limits were based upon.

Following the New York incident, then Governor George Partaki demanded that the Coast Guard revise its weight standards and directed New York to raise its weight standard to 174 lbs. per passenger for tour boats.

While the Coast Guard was initially slow to respond in 2006 it recommended a new standard of 185 lbs. per passenger for small commercial boats. This is still under review, and to date there has been no mention of amending the weights for recreational boats.

It is glaringly apparent that there is an obesity epidemic in the U.S. affecting children as well as adults. I have been involved in Aviation Safety issues for over fifty years. I have written many articles addressing the obese passengers that require a seatbelt extension to meet the *fasten seatbelt FAA rule*. The coach passenger seated next to a grotesquely obese person who has not purchased two seats and is encroaching on your terrotory has two alternatives, move to another seat, if none available get off the aircraft. Aircraft weight is an economic as well as a safety factor. I have argued—why should a 150 lb. passenger pay the same fare as a 350 lb. passenger!

The safety conscious boater should take the prudent course and apply the aforementioned weight criteria, especially on boats of 26 feet or less. Use common sense and not the outdated capacity plate when loading your boat. Should the state of California follow that of the state of New York?———You bet, considering the rate of increasing obesity in our society.

Following lunch there was a very good presentation on the charting of the New Ferry Routes, America's Waterway Watch, S F Harbor Safety, and Vessel Traffic.
