The series is open to spinnaker and non-spinnaker monohull and multihull yachts of 20 feet LOA or greater. Scoring will be by the low point system with one throw-out after 4 races. The Race Committee will provide a fleet and possibly a separate start when 5 or more of a one design boat register before the first race in the Series. Protests will be heard through arbitration in accordance with RRS Appendix T5 first. If the issue is still unresolved, a formal protest may be pursued. Prizes will be awarded based on the number of entries in each fleet.
