TREASURE ISLAND YACHT CLUB

CONSTITUTION

ARTICLE I: NAME AND AUTHORITY

- Section 1. The name of this branch of the U.S. Naval Sailing Association is and shall be the TREASURE ISLAND YACHT CLUB (TIYC).
- Section 2. The burgee of the TIYC shall be a pennant with a blue field and a gold horizontal stripe running from the hoist to the point; the gold stripe having a vertical height equal to 1/4 the vertical height of the hoist. The gold stripe will bear the letters "TI" in blue and measuring 2 1/2" in height placed horizontally 3" from the hoist band.
- Section 3. This Club is established and shall be operated pursuant to the provisions of the following regulations:
 - a. Constitution and By Laws of the U.S. Naval Sailing Association.
 - b. BUPERSINST 1710.11.
 - c. Commanding Officer, Naval Station, Treasure Island directives concerning special services activities.

ARTICLE II. OBJECTIVES

- Section 1. To encourage and advise the Commanding Officer in the promotion of recreational and competitive boating and sailing, as a part of the special services program.
- Section 2. To promote seamanship, piloting, navigation and water safety.
- Section 3. To encourage and establish liaison between members of the Club with local yacht clubs and other branches of the U.S. Naval Sailing Association.
- Section 4. To organize opportunities for members to take part in all forms of yachting and boating and to furnish members with advice and information.

ARTICLE III. MEMBERSHIP

- Section 1. The membership of this Club shall consist of Regular and Honorary members.
- Section 2. Regular membership is open to all active duty uniformed services personnel, retired personnel, reserve personnel including those in a retired reserve status and their dependents, and civilians who are employed by the Navy/Marine Corps aboard Treasure Island holding current Special Services "Gold Cards."

- Section 3. The following privileges shall apply to Regular membership:
 - a. May vote at all general meetings of the Club, in person or by proxy, and participate in all events and activities sponsored by the Club.
 - b. May fly the Club burgee as appropriate.
 - c. Will receive the regular mailing of the newsletter, "JIBE."
 - d. Will receive an official membership card.
- Section 4. Honorary membership may be bestowed for one year by the Commodore. The Commanding Officer, Naval Station, Treasure Island will be an honorary member. Honorary members may not vote; however, they shall have all other privileges of regular members.
- Section 5. All members shall be listed in a directory of members to be maintained by the Club Secretary.
- Section 6. Regular membership shall be terminated automatically when eligibility ceases to exist or when voted by at least seven (7) members of the Bridge.

ARTICLE IV: MEETINGS

- Section 1. General meetings shall be held on the third Monday of each month unless otherwise directed by the Commodore.
- Section 2. Bridge meetings shall be held at the call of the Commodore, or acting Commodore, to conduct such business as may be necessary. This will usually be on a monthly basis.
- Section 3. Special meetings may be called at the request of one-fifth of the regular membership. At least five (5) members of the Bridge must attend a meeting called under this section.
- Section 4. One-fifth of the regular membership shall constitute a quorum for general and special meetings called under sections 1 and 3 above, providing that at least five (5) members of the Bridge are present.

ARTICLE V: OFFICERS (BRIDGE)

- Section 1. The officers of the Treasure Island Yacht Club shall consist of a Commodore, a Vice-Commodore, a Rear Commodore/Racing, a Rear Commodore/Cruising, a Rear Commodore/Training, a Secretary and Treasurer; a Steward, Historian, Watch Captain and Fleet Captain shall be appointed by the Commodore. All shall be considered members of the Bridge.
- Section 2. These officers will be elected during the fall quarter and will serve from 1 January to 31 December.

- Section 3. Vacancies will be filled by the Bridge on an interim appointment basis.
- Section 4. The elected officers may appoint additional Bridge members as required.

ARTICLE VI: DUES

Section 1. The Club is to be operated as a non-profit organization. The administrative expenses shall be met by the payment of annual dues.

ARTICLE VII: ADOPTION

Section 1. This Constitution becomes effective immediately upon being approved by a two-thirds vote of the members present at the next general meeting and signed by the Commanding Officer, Naval Station, Treasure Island.

ARTICLE VIII: AMENDMENTS

- Section 1. An amendment to the Constitution must be carried by a two-thirds vote of the voting members present at a regular or called general meeting and approved by the Commanding Officer, Naval Station, Treasure Island.
- Section 2. Written notice of the proposed amendments must be published to the members of the Club at least ten (10) days prior to being considered. In the absence of such notice, an amendment shall not take effect until ten (10) days following the meeting at which adopted, provided that no objection is received from any five (5) absent members in the interim period.

This Constitution is hereby approved.

TREASURE ISLAND YACHT CLUB

BY LAWS

CHAPTER 1. DUTIES OF CLUB OFFICERS

Section 1. The Commodore shall manage the affairs of the Club in accordance with the policies and directives of the Bridge. This includes the formulation of an annual budget.

He shall call special meetings of the Club whenever he shall deem it necessary, or upon the written request of 20% of the voting members in good standing. He shall jointly, with the Treasurer, execute all disbursements and such contracts as the Club may require. The Commodore shall be an ex-officio member of all committees.

- Section 2. The Vice-Commodore shall assist the Commodore in the discharge of his duties and to officiate in his absence. He shall be Chairman of the Membership Committee, Entertainment Committee and Nominating Committee.
- Section 3. The Training Rear Commodore shall provide assistance to and coordinate with the Marina Manager to determine the qualification level of authorized users of Naval Station, Treasure Island special services rental boats. He shall refer to BUPERSINST 1710.11 for the minimum qualification requirements. He shall be the Qualifications Committee Chairman.
- Section 4. The Racing Rear Commodore shall be the Race Committee Chairman, direct racing activities of the Club and work with the Training Rear Commodore on special projects.
- Section 5. The Cruising Rear Commodore shall be the Cruising Committee Chairman and work with the Vice Commodore to facilitate all social events.
- Section 6. The Secretary shall keep membership records and correspondence records of the Club and the minutes of all meetings. The Secretary will be responsible for publishing the "JIBE," the monthly newsletter of the Club.
- The Treasurer shall be custodian of the funds and financial records of the Club. He shall jointly, with the Commodore, execute all disbursements and such contracts as the Club may require. Should the Club be officially dissolved, he will turn over all residual funds in the Club Treasury to Special Services, U.S. Naval Station, Treasure Island, designated to be used solely for the purchase of boats for Treasure Island. He shall keep the Bridge informed concerning financial assets, liabilities and membership dues delinquencies.

Section 8. The Steward shall be responsible for:

- a. Changing the locks on the clubhouse door annually just prior to the February general meeting.
- b. Ordering old and new Bridge member flags.
- c. Control of door keys, utilizing a key log. Steward may sign out a certain number of keys to watch officers for weekend key assignments to members unable to attend meetings. Watch officer would turn in keys not issued and/or money for keys issued at end of weekend.
- d. Operation of resale activity for beverages, food and items of clothing, burgees and patches as directed by the Bridge.
- e. Reconciliation of phone bills with the phone log and providing names of those owing the Club for phone calls to the Secretary to be published in the JIBE.
- f. Accountability and maintenance for all clubhouse property.
- Section 9. The Historian shall compile and maintain old records, documents, pictures and other memorabilia in chronological order as an archive of the Club's past.
- Section 10: The Watch Captain shall organize watch bills for weekends and holidays. The watches shall consist of volunteers from the regular Club membership and be manned as directed by the Watch Captain.
- Section 11. The Fleet Captain shall act as the liaison between the Club and the Marina Manager, under the joint direction of the Racing and Training Rear Commodores, concerning preventive and corrective maintenance of special services rental boats. He shall be responsible for ensuring that all Rhodes 19 racing equipment is clean, dry and in good repair. This includes that equipment assigned to the "dry hull" boat, RASCAL. He shall also assist the Training Commodore in preparing and presenting classes on racing.

CHAPTER II. COMMITTEES

- Section 1. There will be two types of appointive committees established. Standing committees are of a permanent nature and will function on a continuing basis. Temporary committees will be established to meet specific requirements and will be dissolved upon the conclusion of their business. Members of the committees will be appointed by the Bridge as required in the accomplishment of their duties.
- Section 2. Standing Committees are:
 - a. Qualification Committee to evaluate the Naval Station training program and to test the sailing qualifications of special services boat users.

- b. Race Committee to plan for and conduct races.
- c. Cruising Committee to plan for and conduct cruises.
- d. Entertainment Committee to plan for and conduct social activities.
- e. Membership Committee to enroll eligible persons into the TIYC to become members and to conduct recruiting activities as may be desirable.
- f. Nominating Committee shall meet in the month of October of each year under the direction of the Vice Commodore who shall appoint no less than five (5) persons to nominate candidates for the positions of officers, to be chosen in November by a vote of the regular members to serve for the coming year.

CHAPTER III: REMOVAL FROM OFFICE

Section 1. Should any officer be deemed guilty of gross misconduct, charges may be preferred against him/her in writing by any regular member in good standing. The Bridge shall convene a special meeting to consider the charges and hear any additional testimony by all parties involved. Should charges be accepted by the Bridge, the guilty officer may be relieved of his/her office by a consenting vote of not less than seven (7) members of the Bridge.

CHAPTER IV: AFFILIATION

- Section 1. The Club will maintain membership as a branch of the United States Naval Sailing Association (USNSA).
- Section 2. The Club will maintain membership in the Bay Area Naval Sailing Association (BANSA).
- Section 3. Regular membership in the Treasure Island Yacht Club shall

 NOT include membership in the USNSA. It will be up to each individual to apply directly to the United States Naval Sailing Association, if such affiliation is desired.

CHAPTER V: FINANCIAL

- Section 1. Annual dues shall be \$9.00 for single membership and \$12.00 for family membership, payable no later than 31 January for the coming year. Persons becoming members during the year will pay on a prorated basis (number of months left in calendar year \$.75/month for singles, \$1.00/month for families).
- Section 2. To prevent loss to the Club treasury, all members making reservations for Club events are liable for payment whether or not they participate in the event unless cancellations are made at least 48 hours in advance of the event. All sailing cancellations must be made at least 48 hours in advance of the

scheduled event.

- Section 3. Any member making financial commitments obligating the Club must obtain approval from at least five (5) Bridge members.
- Section 4. Members shall be expected to reimburse the Club for any phone calls.
- Section 5. Keys shall cost new members \$5.00 each (\$2.00 refundable when member turns key in and does not renew membership). Lost keys will cost members \$3.00 each to be replaced.

CHAPTER VI: EXPULSION

- Section 1. A member may be expelled or suspended from membership in the Club for conduct injurious to the welfare of the Club.
- Section 2. Expulsion requires the approval by open vote of two-thirds of the voting membership present. The member concerned has the right to appear before the Club in his own defense.
- Section 3. Expulsion proceedings may be initiated upon the written complaint of three or more members.
- Section 4. Initial suspension can be effected by a Club officer, but must be confirmed by an open vote of the membership at a called meeting within seven (7) working days. Upon oral notice of suspension by a Club officer, the member concerned immediately loses all Club privileges until a special meeting is called and the membership rules on the case.

CHAPTER VII: ADOPTION

Section 1. These By Laws become effective immediately upon being approved by a two-thirds vote of the members present at the next general meeting and signed by the Commanding Officer, Naval Station, Treasure Island, San Francisco, California.

CHAPTER VIII: AMENDMENTS

- Section 1. An amendment to these By Laws must be carried by a two-thirds vote of the voting members present at a regular or called general meeting and approved by the Commanding Officer, Naval Station, Treasure Island, San Francisco, California.
- Section 2. Written notice of the proposed amendments must be published to the members of the Club at least ten (10) days prior to being considered. In the absence of such notice, an amendment shall not take effect until ten (10) days following the meeting at which adopted, provided that no objection is received from any five (5) absent members in the interim period.

These By Laws are hereby approved.
