## FROM THE COMMODORE John Miller

As announced in last month's Jibe, we are instituting an organized volunteer program, where members are assigned a committee task. At last month's meeting, those present met together with their committee members and began planning things to do. As stated in the Jibe, our intention is to get members involved for three reasons; first, the jobs to be done can be spread over a larger group, thus lessening the individual workload; second, new ideas and initiatives will come to us as more of our members become involved; and three, the perceived notion that power and control is centered in a small group will be dispelled. It is our intention to get all members that are practically available assigned and involved in the program. If you haven't yet seen your name assigned, you will.

The Board of Directors has appointed a nominating committee for the purpose of recommending a slate of officers to the membership for next year. The Board has also established that the dues for next year will remain at \$125. This amount was arrived at because, although as yet we are not required to pay any rent or utilities, we are told that we will. Further, it is my belief that within the next 4 to 14 months we will convert to a civilian yacht club, at which time we will lease this building from the City of San Francisco. We will then be paying rent to them as well as paying for our

utilities. As is envisioned by your leadership, at the appropriate time within this time frame, we will ask the City Redevelopment Agency to request the Navy to declare this building no longer needed by the Navy, thus making it immediately available for acquisition by the City. We will then enter into an interim lease of this City property and become a "new" yacht club. As agreed to last October, those members not party to the Building Fund will, at the beginning of next Club fiscal year after we become a civilian Club, have the option of discontinuing their membership or reapplying for membership as new members, paying the appropriate building fund assessment and initiation fee. I really think this transition can happen sometime during our 1996 fiscal year. We must accomplish the transition as soon as we can so as to establish our firm presence on the Island, but delay it as long as possible so as to incur as little expenses in the way of rent/utilities as we can. When we are leasing our building, we can begin working with the City on plans to remodel or rebuild, if that is what the membership wants to do. All of the foregoing, in more detail, is being presented to the City as a Master Plan for the Treasure Island Yacht Club. I will keep you informed of further progress.

SOME INFORMATION ABOUT RADIO TELEPHONE PROCEDURES: Submitted by Bob Becker, taken from the USCG Local Notice to Mariners, 9 May 95.

UNDERSTAND AND FOLLOW THESE PROCEDURES AT ALL TIMES:

- Channel 16 may only be used for distress and calling.
- Keep all calling to an absolute minimum on Channel 16.
- 3. It is **ILLEGAL** to use Channel 16 for radio checks.
- 4. **LISTEN** before transmitting don't interfere with other stations calls.
- 5. Don't call Marine Operators on 16. Use working channels.
- 6. Children should be taught how to operate a radio in case of emergency.
- 7. Children should also be taught that a RADIO IS NOT A TOY.
- 8. Use LOW POWER as often as possible.
- NO unnecessary communications are permitted on VHF
- 10. Use your FCC assigned call letters at the beginning and end of transmissions.
- Never use a Telephone Credit Card on your VHF - other's can hear your number. Use a Marine Telephone Identification No. (MIN)
- Your VHF must be licensed. If you cruise outside US waters, you must have an operator's license.

Out of 100 cries of distress, only three are real! Increase someone's chances of being saved by not sending the rescue forces out chasing FALSE ALARMS. Check your EPIRB. Make sure it is off. **NEVER CRY WOLF!** 

# CRUISE NEWS Len Cardoza

For Crew Cardoza, Treasure Island Yacht Club's cruise to Half Moon Bay started on Friday

night, April 21. I had just arrived home after a week of travel to greet **Barbara's** visiting parents and catch the weather on the 11:00 PM news. It seemed that the weather "window" was perfect, forecasting light winds and mild temperatures. The cruise was a "GO".

Visiting and packing left us with only a few hours sleep. We arrived at the Marina just before 7:00 on Saturday morning to start preparing *Kachina* for her first "off shore" passage. I wandered up to the club at 7:15 in search of a cup of coffee and expecting to see two or three people at the skippers' meeting. Imagine my surprise to see the club full of people from 13 sailboats committed to the adventure!

Terry and Marion Sigel, the cruise leaders, had prepared a list of waypoints. Terry gave a comprehensive safety briefing, answered questions about schedule and course, and we were off, departing TIYC about 8 in the morning.

We caught the ebb, departing San Francisco bay in light winds with most of the fleet motorsailing. Barbara and I had doused **Binnacle and Bilgewater** with Dramamine, unsure on how the urchins would react to the anticipated 5-10 ft. Pacific swells. They were zonked out in their respective bunks by the time we sailed under the Golden Gate bridge. This stuff works great! We should try it at home! For good measure, we took some ourselves.

The seas were a bit bouncy outside the Golden Gate, but the motion became almost pleasant as we turned south at the bar channel. We found ourselves struggling to stay awake as we motorsailed south, with faithful "Tristan" our autohelm, steering a steady course. The scenery was magnificent. We sailed by the infamous "Devil's Slide" and the magnificent Point San Pedro, assisted by a 1-1 1/2 knot favorable current.

Following Terry's accurate waypoints, we rounded Buoy "1" at Half Moon Bay, enthralled by the sight and sound of the Pacific swells breaking over the outer reefs. Binnacle had just awakened, struggled into her PFD (personal flotation device), and come up into the cockpit.

Watching the large blue breakers, she asked "Are we in Hawaii?"

Entering Pillar Point Harbor, we received the expected news that the harbor was at "110% capacity" due to the start of the commercial salmon season. One group of the TIYC fleet opted to anchor out. A second group, including *KACHINA*, rafted out from commercial fishing boats at end ties. The remainder of the fleet found spots at various places in the harbor.

Barbara and I were completely charmed by Half Moon Bay. We had visited before by car, and Pillar Point Harbor together with its stout breakwaters, were part of my responsibilities in the Corps of Engineers. Nevertheless, there is some special quality associated with entering such an extraordinary place by sea.

We enjoyed talking with the fisherfolk and marveled that entire families were preparing for a hard season, some fishing under sail. We also enjoyed spending time with the townspeople of El Granada and partook of the hospitality of the Half Moon Bay Yacht Club.

Imagine the consternation of the small restaurant staff of "Ketch Joanne" when I requested evening reservations for 30 people! We worked things out by arranging for two different seatings. Actually, this worked out great since people preferred dining at different times anyway.

We awoke Sunday morning to thick fog. After breakfast and a long walk on the beach, we departed Pillar Point Harbor at 10:20, sailing in company with *GRAND ILLUSIONS*. Ahead were the first group, led by *SPIRIT*. The remainder of the fleet departed behind us. Following Terry's waypoints, we sailed out of Half Moon Bay, listening with apprehension to the breakers and relief at the gonging buoys appearing out of the fog when and where expected.

The wind died about 3 miles out of Pillar Point, and we proceeded North, motorsailing against the same current that helped us the previous day. We sighted dolphins and the occasional

wayward sport fishing boat. Several members of the TIYC fleet reported sighting whales.

We sailed out of the fog opposite Pacifica, and crossed the San Francisco Bar to catch the afternoon flooding tide. The engine was shut down as the usual W-NW wind gave us a great ride all the way back to the Marina.

A special thanks to **Terry and Marion Sigel** for leading us on a memorable cruise!



The Coast Guard will record a first when the new Z-drive propulsion system is installed on the new Keeper-Class buoy tenders currently under

construction at Marinette Marine Corp.

These 175-foot coastal buoy tenders will be outfitted with twin Z-drive diesels with fixed-pitch propellers. Wisconsin based Marinette Marine Corp., is building the new buoy tenders, the first one of which will cost \$22 million. They will be equipped with Ulstein Z-drive units directly shafted to a pair of Caterpillar diesels.

The selection of Z-drives propulsion for coastal buoy tenders was based on dynamic positioning requirements for installation of aids to

navigation.

Z-drive propulsion is similar to an oversized johnboat, the type that has one or two outboards in a well about two thirds of the way back from the bow. Z-drives along with a bow thruster will provide the best maneuverability for maintaining position in coastal waters while servicing aids to navigation. The two main diesels will deliver an output of 885 hp per unit, which will drive two propellers through right-angle azimuthing propulsion thrusters, with each engine directly shafted to its Z-drive. A 400 hp electric bow thruster will be installed, which when working together with the Z-drive will allow the vessel to virtually spin its own length.

The first Keeper-class vessel, to be named *Ida Lewis*, is expected to be delivered in January 1996. After sea trials the vessel will sail to Boston or

Rhode Island for initial deployment.

CWO Mark Allen of St. Petersburg Florida will be her first skipper. He has commanded three other Coast Guard buoy tenders during his nearly three decades in the service.

#### WOULD YOU BELIEVE?

Possible cause of the following accident

#### FLATULENCE ATTACK!

Columbus Islen, a 289 ton research vessel owned by the National Science Foundation and under charter to the University of Miami, grounded in Looe Key National Marine Sanctuary (Looe Key is located 20 miles east of Key West.

She was on a 14 day oceanographic cruise when she went aground. She had 21 scientists on board from Woods Hole Oceanographic Institution,

as well as some foreign scientists.

She smashed across four coral spurs - coral formations that grow up to 330 feet in length. The

weather was clear, with winds at 20 knots, seas running three to four feet. The Captain and one crewman was on the bridge at the time of the grounding. Several vain attempts were made by the Captain to back clear, before she became hard aground.

Salvage crews stated that the ship was loaded with navigation equipment; "she's got every type

of antenna known to man."

The Captain stated that he "blacked out" for six minutes just prior to the grounding and could not remember the events. He later recanted this statement and instead said that he had not blacked out and that he was not going to make any further statements.

Coast Guard officials would not release any information on the possible cause of the grounding due to the ongoing investigation. It appears that all bridge navigation equipment was operational prior to the grounding and there were no equipment or mechanical problems that could have contributed to the accident.

Damage estimates to the ship run between \$500,000 to \$1 million.

During the two days that the *Columbus Islen* pounded the reef, a 500 by 30 foot section of coral was destroyed. The time spent aground was punctuated by disagreements and uncertainties between would-be salvagers, environmentalists and Coast Guard officials who took charge several hours after the grounding

Two crewmembers have indicated that both the captain and the seaman on watch had walked out to separate bridgewings immediately prior to the grounding because of offensive odors in the relatively confined wheelhouse. The incident occurred just moments before the vessel, operating

on autopilot, went aground.

Reports indicate that the vessel's skipper was so embarrassed by the incident that he immediately asked to be relieved of command and subsequently surrendered his 1,600-ton license to Coast Guard officials.

Reports indicate that the captain had grounded the same vessel previously and was operating under informal 'probation' as set forth by the vessel's owners.


"We kept this quiet from everyone," said one of the ship's crew. "We didn't tell the Coast Guard or anyone until it finally came out when we got into formal depositions with lawyers and all that."
