

COMMODORE'S NOTES

have delayed writing my notes this month for as long as I could in hopes of giving you the absolute latest update of what is happening with your Club and the situation on Treasure Island, but to meet our regular end-of-month publication date here it is Wednesday, September 27th, and "all the news that's fit to print."



We continue to move forward in a positive direction toward returning to a clubhouse at Clipper Cove! At midnight Saturday the Delancey Foundation's lease on Building 298 will expire. At the Treasure Island Development Authority's (TIDA) September 13th meeting in City Hall the Authority's governing board voted unanimously to authorize its staff to enter into "sole source" negotiations with the Treasure Island Yacht Club for lease of the space in Building 298 that we propose to turn into an interim clubhouse pending the final build-out of the new marina. The significance of this vote is hard to overestimate. The vote that day had to be unanimous essentially finding that leasing to the Club is clearly in the best public interest-- otherwise the City would have had to have conducted a public bidding process, which would have resulted in significant delays.

It is appropriate to recognize three friends of the Club who helped make this possible. First, of course is Marianne Conarroe, former Harbormaster, and now a key member of Mayor Brown's Treasure Island staff. She has provided consistent sound advice as to how we might best navigate through the rocks and shoals which surround the Island. A sailor herself, she has helped the rest of the Mayor's staff understand our concerns. Next is the Development Director, Steven Proud during the last year-or-so that he has been on-board he has always worked with us in a friendly and cooperative way to see if we can find a way to return to Clipper Cove. Finally, we are in debt to Randy Short of ALMAR. It would have been easy for him to have simply said "no" to our plans for an interim return to the Cove

and the ballgame would have been over. Instead he gave us a cautious "yes" and we are committed to doing everything we can to continuing a productive and trouble-free relationship with ALMAR.

I met with the City's Department of Building Inspection staff on the morning of Tuesday, September 5th,

while on my way to the annual Administrative Law Judges Association Forum in Monterey. With a few minor exceptions they have tentatively approved our architect's plans for Building 298. DBI's comments have been forwarded to our architect so the he can fine-tune his drawings and comment sheet.

I spent the week of September 18th hearing cases in Southern California, Since I returned Steve Proud and I have been playing "telephone-tag." We need to set up a series of meetings to begin negotiations for the lease. Along with this, we need to insure that the interests of the disabled community are taken into account and respected, and that ALMAR remains an integral part of the decision-making process. As Commodore I will be taking an active part in these discussions as will Kent Brewer, Ted Karavidas, Jim Aberer and George Knies.

Everything I have set out above was discussed at the Bridge & Board meeting on the evening of September 13th following the vote of the TIDA board that afternoon. Hopefully by our next B&B meeting on October 3rd I will have been able to talk with Steve Proud and get a more firm handle as to the City's view of time, money and process. We then will be having a general membership meeting (along with dinner) on Saturday, October 21st, at the Oakland Yacht Club's Regatta Room. Some very significant decisions have to be made directly effecting the future of the Club so please make it a point to be there.

Random Notes:

Your B&B will be discussing our Club's dues structure for 2001 at our meeting on October 3rd (Berkeley Yacht Club 6:30 PM). Nothing has yet been decided, but for existing members things should remain pretty much as they are. The inescapable fact is, however, that we will be needing a larger revenue stream when we return to operations at Clipper Cove. At the very least we will have to cover rent, electricity and insurance. We will also have to begin "ramping-up" for the inevitable costs associated with a permanent facility leased from ALMAR beginning about three or four years from now. How do you think that we should increase revenue? Should there be an initiation fee for new members once we return to the Island? If so, how much? What about a building fund assessment? Again, if so, how much? What revenue-generating activities should the Club engage in once we return to the Island?

Elections will be coming up soon. A nominating committee has been established under Staff Commodore Jim Aberer. Please let him know of your interest or suggestions.

We had a small but wonderful raft-up at Angel Island on the weekend of September 15-17. Vice-Commodore Brewer has promised to say more about it in his contribution to the Jibe. A few more participants would have been nice, though.



Kathy and I arrived Friday at 0800 hours and picked up two moorings bow and stern. We prepared our boat for a weekend stay then kicked back relaxing as we waited for any other arrivals. As most of you who were following the Pacific Cup would have been aware of, this was an unusually light air year due to a high pressure system that covered a wide area of the Eastern Pacific and continued further south than normally expected. But on this trip, the ocean at times seemed like a still lake two thousand miles off shore!

Up until three hundred and fifty miles off the coast of Oahu, the voyage was uneventful - then we could not avoid meeting up with Hurricane Daniel and all hell broke loose! At this writing, all I will say is we were hove to for over 20 hours right in the middle of the "UnPerfect" storm...

FLYING THE FLAG ON U.S. NAVAL VESSELS

A subject that has been making the rounds and making quite a furor. The response to this was published on the U. S. Naval Academy web Page and is as follows:

Flying the Flag

Public Affairs Office- USNA 08/29/00

There is a rumor based on a totally false internet news site saying that the President of the United States is going to direct USN warships to fly the Vietnam flag above the US flag during an upcoming port visit. There is no such plan, no such visit. The USNA AA has been provided the following statement:

"There are no plans to change the regulations governing the flying of the U.S. flag on U.S. Navy warships. Federal statutes determine Navy Regulations on the flying of the national ensign on Navy vessels, and are not subject to alteration by the Department of the Navy."

In addition, National Security Council spokesperson LTC Dave Stockwell stated, "Reports regarding this issue, fed by conjecture on the internet, are complete nonsense. U.S. Navy regulations prescribe that no flag will fly higher than the U.S. flag aboard a U.S. Navy ship whenever that vessel is underway. The president fully supports this policy and has no intention to direct any changes."

Navy Regulations, 1990, Chapter 12

Section 1277, Paragraph 1:
"When the national ensigns of two or more nations are required to be displayed from


the same masthead, the United States national ensign, if required, shall be displayed to starboard of all others. The national ensigns of other nations shall be displayed, starboard to port, in alphabetical order of the names of the nations in the English language; except that the ensign of a foreign nation within whose waters the ship is located, if displayed, shall be to starboard of other foreign ensigns.

Paragraph 3:

"In rendering honors, the national ensign of one nation shall not be displayed above that of another nation at the same masthead." Section 1279, Paragraph 3: "When dressing or full-dressing ship in honor of a foreign nation, the national ensign of that nation shall replace the United States national ensign at the main, or at the masthead in the case of a single-masted ship; provided that when a ship is full-dressed or dressed in honor of more than one nation, the ensign of each nation shall be displayed at the main, or at the masthead in a single-masted ship."

Paragraph 6:

"Ships not under way shall be dressed or full-dressed from 0800 until sunset. Ships under way shall not be dressed or full-dressed."
